Three Month Highlights

- Fiscal Year 2014 -

- **Total ALA Revenue - \$9.5 million**
 - Less than budget by \$1.7 million
- **Total ALA Expenses - \$10.4 million**
 - Less than budget by \$1.7 million
- **Excess Expenses Over Revenues – (\$877,467)**
 - This is the typical Revenue/Expense/Net pattern for this time period. The budget was for a loss of (\$885,879)
- **Cash and Investments - \$17.3 million**
 - More than last year by \$1.3 million at \$16.0 million
- **Endowment Fund - \$37.1 million**
 - More than last year by \$4.6 million at \$32.5 million

Three Month Highlights

- Fiscal Year 2014 -

● General Fund Revenue - \$4.9 million

- Less than budget by \$732,320
- Dues income @ \$1.3 million is less than budget by \$61,681
- Publishing revenue @ \$3.1 million less than budget by \$738,762
 - *lower online sales in ALA Editions/TechSource
 - *lower sales related to library promotions in Products & Promotions
 - *lower royalties in Booklist

● General Fund Expenses - \$5.8 million

- Less than budget by \$318,300

Three Month Highlights

- Fiscal Year 2014 -

- **General Fund Expenses Over Revenues**

- **Net Revenue Loss of (\$960,006)**
- **Budgeted net revenue loss of (\$545,985)**
- **Actual loss is more than the budgeted loss by \$414,021**

Three Month Highlights

- **Division Revenue - \$3.6 million**

- Less than budget by \$206,579
- More than the first quarter in FY13 by \$1.1 million
 - *The AASL conference held in 10/13
- Dues income @ \$678,481 is less than budget by \$3,480

- **Division Expenses - \$3.6 million**

- Less than budget by \$610,412
- More than the first quarter in FY13 by \$656,338

Three Month Highlights

- Divisions Revenues/Expenses/Net Revenue -

Net Revenue	\$ (415,940)	\$ (3,474)	\$ (407,307)	\$ 403,833

Three Month Highlights



- **Roundtables Revenue - \$60,628**
 - Less than budget by \$6,013
 - More than the first quarter in FY13 by \$617
- **Roundtables Expenses - \$19,714**
 - Less than budget by \$26,327
 - Less than the first quarter in FY13 by \$5,489
