The EBSS Tour of the National Library of Education, which was held at ALA's Midwinter meeting in Washington, DC, in 1997 has brought about sharing of ideas of the ACRL EBSS and recognition for several longtime members of our ALA section. Another tour of the new facilities is planned for the Annual meeting there in June, 1998.

The National Library of Education (NLE) is beginning work on establishing the first United States Education Information Network (USEIN). NLE, a unit of the Office of Educational Research and Improvement (OERI) of the U.S. Department of Education, is mandated to develop and implement a national network of education information providers that includes libraries, archives, educational institutions and schools, and other information providers (corporations, associations, organization, agencies). This network, called the United States Education Information Network (USEIN) will be a network of active partners, collaborating on providing education information in all formats, to all customers, in all education related subjects.

NLE is pleased to announce that will have held a two day invitational Kick-Off Conference at Gallaudet University Kellogg Conference Center in Washington DC, November 13-14, 1997, with approximately seventy key public and private sector participants to plan the initial stages of the network. 
EBSS Web Page Has Moved

On June 30th, Nancy O'Brien was presented with the 1997 Distinguished Education and Behavioral Science Librarian Award during the Business Meeting held before the ACRL President's program. One of only five ACRL award winners selected to receive an award before an audience of several hundred, Nancy was introduced by Leslie Bjorncrantz, Chair of the EBSS Award committee. EBSS members who attended the ceremony and the EBSS co-sponsored President's Program also could view the section's new banner hanging proudly on the wall of the hall. (See photo) Leslie's remarks reflected Nancy O'Brien's significant accomplishments:

"On behalf of the members of the Education and Behavioral Science Section, I would like to present the 1997 Distinguished EBSS Librarian Award to Nancy P. O'Brien for her numerous accomplishments in service to the section and for her leadership role in the education library community. We recognize her for her prominent career as head of the Education and Social Science Library at the University of Illinois, Urbana-Champaign; her fifteen years of dedicated service to the section, including two terms as chair; her publications in the area of education information; her pioneering work in increasing national access to historical curriculum materials and textbooks, and her impact as an esteemed colleague, mentor and advisor within EBSS, the State of Illinois, and Nationally".

Nancy was presented with a framed certificate, and acknowledged the recognition from her peers with the following remarks:

"I am deeply honored by this recognition from my colleagues within behavioral sciences and education librarianship. There are a number of people I would like to thank, and I hope they know how much their support has meant. Receiving this award, particularly at this point in my career is very meaningful, and I look forward to many more years of active service with ACRL. Thank you."

After the applause, Nancy received a "thumbs up" from her colleagues. That evening she was the honored guest at the traditional EBSS dinner. Congratulations, Nancy!

EBSS COMMITTEE REPORTS

Committee Reports: Curriculum Materials Centers/ Problems of Access and Control for Educational Materials (CMC/PACEM)

The CMC/PACEM committee met in San Francisco with the major order of business being the disbanding of the PACEM section of the two committees. PACEM (Problems of Access and Control of Educational Materials) was formed as and ad hoc committee of EBSS with the stated purpose of addressing particular cataloging problems in the area of education materials. With the completion of a written article from the PACEM Committee, the CMC/PACEM committee voted to recommend to EBSS that the PACEM committee be disbanded since the stated duty of that committee had been fulfilled. The CMC Committee then addressed the ongoing work of maintaining and updating the Webliography, and assigned members to do the updating. The committee decided that the focus for the committee in the future would be the development of written national standards for CMCs approved by ALA. This issue has been a concern since the CMC Directories were first compiled.

Committee Reports: Distinguished EBSS Librarian Award Committee

This award honors a distinguished academic librarian who has made an outstanding contribution as an education or behavioral sciences librarian through accomplishments and service to the profession. Criteria include service to the organized profession through ACRL/EBSS and related organization, as well as significant library service, research, planning, implementation in academic library programs in education and the behavioral

Committee Reports: EBSS Government Policy Committee

At the San Francisco annual meeting the committee continued to consider its charge. Recognizing that possible overlap with other ALA efforts might entail diminished committee role(s) or even terminating the committee, the central issue discussed was the committee charge and what should be done to make recommendations to the EBSS Advisory Council. We considered what other ACRL groups were doing pertaining to related government issues. After considerable discussion, the committee decided to do the following:

- a. Continue to gather information about other government policy monitoring efforts within ALA/ACRL by looking at the ALA handbook for relevant groups and charges.
- b. Send queries to everyone on the EBSS list asking for opinions and/or comments concerning two key components of the Committee's charge. The components are "To monitor federal legislation and other governmental issues of interest to the EBSS Community.," and to "report back to the EBSS membership ..." Specifically, via e mail input would be solicited from those on the EBSS listserv the following: 1. What concerns do you have about federal legislation as it pertains to or impacts libraries in Education and the Behavioral Sciences? 2. What other government issues are you concerned about as these pertain to or impact libraries in Education or the Behavioral Sciences?
- c. Use this information to develop recommendations for committee action.

Committee Reports: Instruction for Educators Committee

The Instruction for Educators Committee made tremendous progress on its proposed publication Connections: Ideas for Librarian Faculty Collaboration. The Committee, inspired by exciting possibilities reached an agreement on a number of critical points and mapped out a general strategy for proceeding with the project. For instance, the group decided that Collaborations would appeal to a broad range of interests and therefore, should focus on the wider field of the social sciences. There will be seven general sections: an overview of the topic; a literature review; a directory of print and electronic resources; "collaborations in the field," (brief summaries and contact information of successful and still to be solicited collaborations); case studies; what works and what doesn't work (an etiquette for collaboration); and a final section on the future of collaboration in the context of technological change. Each of the nine committee members present volunteered to take responsibility for developing and defining one of the sections. Much work on Collaborations will occur among members by e mail. Within the next few months, the Committee will submit a proposal to the Publications Committee, as well as a grant request to ACRL. Additionally, the IE Committee has agreed to host the Midwinter Discussion on the topic of librarian-faculty collaboration.

Committee Reports: Membership and Orientation Committee.

Charles Thurston, University of Texas at San Antonio, San Antonio, TX

The minutes of the 1997 Midwinter meting were approved. Charles Thurston announced that the annual conference program did not carry a listing of the EBSS Social Hour because it conflicts with a "no conflict" time slot. Revision of the Manual: Although the May 1997 issue of the EBSS newsletter contained a request for committee chairs to forward any revised charges to the committee, none were received. Charles Thurston will delegate M & O committee members to contact specific EBSS committees before 1998 Midwinter. The Committee also agreed to update other sections of the manual under each committee description, e.g. the "Publications" and "Chairs" sections, for historical usefulness. Revision of the membership brochure: Nancy O'Brien will check on ACRL's funding cycle for applying for monies

The ACRL Membership Qualitative Research Report was tabled as a discussion item.

Committee Reports: Nominating Committee

The committee reviewed various publications sent to Charles Thurston by Elisa Topper at ACRL as a guide for both the committee and the candidates. The committee discussed the direction that the Test Collections project should take, and agreed that a directory of institutions holding tests collections would be a beneficial publication to the membership, as well as to researchers. It is envisioned that the directory will be in electronic form, perhaps an edition in paper. Several members volunteered to work on this project, and the issue was taken to the EBSS Advisory Council Meeting. The project was supported there, and the decision was to form an Ad Hoc Committee to produce the Directory. Nancy O'Brien and Paul Fuhrmann will co chair the Test Directory Ad Hoc Committee.

A major portion of the meeeting was spent in a discussion with Wayne Weiten, president oof the Society for Teaching of Psychology, concerning areas of mutual interest and possible collaboration, emphasising activities related to instruction in library use for psychology students. The discussion will continue, and Weiten is recommending that the Society have an appointed liaison to the Psych/Psych Committee who will continue to work with us on the issues.

The Executive Committee approved, with only minor changes, two documents originally drafted by the previous Chair of the Publications Committee, Joan Fiscella. These documents, the EBSS Homepage Policy and the EBSS Homepage Publications Review Policies and Procedures, now bring EBSS electronic publications into the regular publications process.
