## EBSS Chair Report

As I wrap up my time as chair of EBSS, I reflect on the many accomplishments we have made this past year. I want to start by congratulating our newly elected EBSS Vice-Chair Yu-Hui Chen, who will work closely with incoming EBSS chair, Samantha Godbey. I also congratulate our newly elected EBSS member-at-large Hui-Fen Chang. Welcome to you both and I look forward to working with you next year as past-chair.

This year the <u>EDI Task Force</u> completed its work to "identify best practices and advocate for actions related to equity, diversity, and inclusion in academic librarianship, especially as related to education and behavioral sciences librarianship." Based on the task force's final report and recommendations, the EBSS Executive Board voted unanimously in favor of forming a standing EDI Committee that will commence in July of this year. We look forward to the knowledge that this committee will create in areas including recruitment, advancement, engagement, and retention of underrepresented groups in education and behavioral sciences librarianship. A huge thank you to Samantha Godbey for chairing this task force and producing an expertly written report.

The charge for the EDI Committee will be "To identify, advocate for, and implement actions related to issues of equity, diversity, and inclusion in education and behavioral sciences librarianship and EBSS, including: promoting the recruitment, advancement, engagement, and retention of underrepresented groups; communicating about EDI work within the section; collaborating with EBSS committees to develop strategies for integrating anti-oppressive and antiracist practices into the work of their committees; and advising the EBSS Executive Committee on programming, practices, and actions in support of these equity, diversity, and inclusion efforts."

In addition, EBSS partnered with the Digital Services Section (DSS) to present an online discussion forum titled "Data Visualization for Social Justice" on May 16th.

# Communication Studies Committee

The ACRL Board of Directors approved the <u>Companion Document to the ACRL Framework for Information Literacy for Higher Education: Journalism (PDF)</u>, which presents knowledge practices and dispositions important for information literacy within journalism.

We co-wrote and co-sponsored an accepted panel submission at the 2022 American Library Association Annual Conference, "Stronger Together: Perspectives on Mis- and Disinformation from Professional Communities Outside the Library," with ACRL's Politics, Policy and International Relations section. The session will take place Saturday, June 25th, from 2:30-3:30 PM ET.

We are brainstorming a possible panel presentation (with co-sponsors) for fall 2022, comprised of librarians, reporters/journalists, marketing/publicity experts, and others with expertise around current issues and future directions in media representation. We are also collaborating with the Electronic Resources in Communication Studies Committee to add resources on media representation to the ACRL/EBSS Library Resources for Communication Studies (LRCS) guide.

The EBSS Education Committee worked on three different projects this year:

Since announcing significant updates to the <u>Education Guides Repository</u> last fall, the LibGuides sub-committee continues to add related guides on different education topics. We welcome more submissions to help grow this resource to support education librarians. The submission form is on the landing page of the Education Guides Repository, and is also <u>accessible here</u>.

An article by current and former EBSS Education Committee members on the job roles and responsibilities of education liaison librarians was finally published! This article was based on a 2019 survey of education librarians, primarily in the United States. You can read the article in *Education Libraries* here.

The webinar sub-committee continues to partner with the Special Library Association (SLA) Academic and Education Community to offer webinars on education-related topics. This year's webinars (July 2021 to May 2022) have covered a wide range of topics, including juvenile collections, outreach opportunities for college students with intellectual disabilities, digital badges, and more. # Equity, Diversity, and Inclusion (EDI) Task Force

The EBSS EDI Task Force has completed its work and submitted its recommendations to the EBSS Executive Committee in their final report, which can be read in full on the newly created EBSS EDI LibGuide. In 2021, the task force gathered input from committee chairs in the spring and distributed a survey to EBSS members in the fall to get a better sense of the work already taking place related to EDI across EBSS and to determine areas for improvement. One of the task force's recommendations was to establish a standing EDI committee as part of a commitment to actively move forward with the work of improving the section with regards to equity, diversity, and inclusion. This committee was recently approved by the EBSS Executive Committee. EBSS members interested in serving on the standing EDI Committee should contact Samantha Godbey, chair of the EDI Task Force and vice-chair of EBSS, to indicate their interest.

### **ERIC Users Committee**

The EBSS ERIC Users Committee held a virtual meeting on April 25, 2022 with all committee members in attendance to discuss the proposed dissolution of the committee. Reasons for disbanding the committee include few current or recent members; no major concerns about the ongoing status of ERIC at the federal level; and, no 2022 committee volunteers. If the committee disbands, its activities could be reassigned to other EBSS committees or a task force created if concerns arise about ERIC. Reasons discussed for retaining the committee are possible delays in creating a task force if there is an immediate threat to the ERIC database and project, and that EBSS may lose direct contact with the federal ERIC project director who shares updates about changes. After extensive discussion, assurance that EBSS will reassign interested committee members to other EBSS committees, and a report from the ERIC project director that timely communication to constituents through EBSS will continue, the committee unanimously voted to dissolve.

#### **ERIC USERS REPORT CONTINUED**

While this is a bittersweet decision for a committee established in 2004 to respond to federal funding cuts and content restrictions to ERIC, it is also a decision that reflects leadership from EBSS in maintaining a vibrant organization that can adjust for changes over time. The EBSS Executive Committee will review this vote and make its final decision in summer 2022.

# Instruction for Educators Committee

The EBSS Instruction for Educators Committee hosted a discussion event in December 2021 to gather feedback on the first draft of our framework companion document. We used the rich feedback from participants to create a greatly improved second draft of the document. See the current draft at <a href="https://acrl.libguides.com/ed/Welcome">https://acrl.libguides.com/ed/Welcome</a>. We also asked for feedback via web form. While the form is now closed, you can still send comments to Robin Ewing (rlewing@stcloudstate.edu). Our next step is to review comments from the form and revise the document as needed with the goal of submitting our document to EBSS leadership.

We are also working with the ACRL Standards Committee to determine when is the appropriate time to rescind the former <u>Information Literacy Standards</u> <u>for Teacher Education</u>. The standards for teacher education were built on the broader <u>Information Literacy Competency Standards for Higher Education</u>. Although the broader standards were rescinded in 2016, this did not carry over to discipline-specific standards. Additionally, new framework companion documents are not considered a direct replacement of discipline-specific standards, so we need to complete a formal rescinding process.

# Online Learning Research Committee

This semester, the EBSS Online Learning Research Committee wrapped up a multi-year research project which surveyed members of EBSS for their perceptions of online librarianship before and after the change to remote work due to COVID-19. Our resulting paper, titled "Crisis Librarianship: An Examination of Online Librarianship Roles in the Wake of the COVID-19 Pandemic" was accepted for publication in the July 2022 issue of *The Journal of Academic Librarianship*. We will be presenting the results of this study at two conferences, both to be held in May 2022: the EBSS Virtual Research Forum and the International Conference on Qualitative and Quantitative Methods in Libraries. We offer our deep appreciation to the members of EBSS who took the time to complete our survey. We hope the results of our study will provide valuable representation of EBSS members' experiences within the professional literature.

Beginning in March 2020, the authors noticed pronounced differences to their workload in terms of a greater emphasis on online librarianship tasks. To investigate, this research began with a literature review to understand the challenges of online librarianship during the pandemic, both domestically and internationally. Then, a mixed methods study incorporating quantitative methods, a survey of online librarianship duties and perceptions both before and after March 2020, and qualitative data sources were developed to understand the post-lockdown work environment of EBSS members. This lightning talk will share the findings of the study, with some implications including lessons learned from less economically developed nations profiled in the literature review.
