Dear Chairman Kline, Ranking Member Scott, Chairman Alexander and Ranking Member Murray:

On behalf of the American Library Association (ALA), I am writing in strong support of S. 1177, the Every Student Succeeds Act. We are encouraged by your efforts to complete reauthorization of the Elementary and Secondary Education Act (ESEA) and are optimistic that improvements contained under S. 1177 that include effective school library programs will help ensure that all students graduating from America's schools will be adequatley prepared for college and success in the workforce.

As poverty rates across America remain high, our schools must serve as an "equalizer" that provides all students with access to the resources and instruction they need to succeed academically and become productive and engaged citizens. Effective school library programs are a wise investment, but in too many schools across the nation, school library budgets and school librarian positions are being cut. This puts our children's education and workforce readiness at peril.

In addition, recent data¹ available from the Department of Education's National Center for Education Statistics (NCES) highlights the lack of support for too many of our students in thousands of schools across the country. NCES data reveals that approximately 8,830 public schools across the nation do not have a school library and for those schools that do have a library, nearly 17,000 schools do not have a full or part-time state-certified school librarian on staff.

ALA has been disheartened by this lack of support for effective school library programs and comprehensive literacy instruction at the federal, state, and local levels because schools with effective school library programs ensure their students have the best chance to succeed.

Accordingly, ALA is encouraged that multiple provisions included as part of S. 1177 would support effective school library programs:

- Title II, Part B, Subpart 2, Section 2226 continues activities currently implemented through appropriations legislation and authorizes Innovative Approaches to Literacy (IAL) that would promote literacy programs in low income communities. Funds are authorized for the development and enhancement of effective school library programs, which may include providing professional development for school librarians, books, and up-to-date materials to high need schools.
- Title I LEA Plan includes a description of how the LEA will assist schools in developing
 effective school library programs to provide students an opportunity to develop digital
 literacy skills and improve academic achievement.
- Authorizes state and local uses of funds under Title II, Part A (Supporting Effective Instruction) for "supporting the instructional services provided by effective school library programs."
- Uses of funds under Title II, Part B, Subpart 2 (Literacy Education for All, Results for the Nation) include coordination with, and professional development for school librarians.
- Eligible entities under Title II, Part B, Subpart 2, Section 2232 (Presidential and Congressional Academies for American History and Civics) include libraries.
- Authorizes states to use funds to assist LEAs with identifying and addressing technology readiness needs, including Internet connectivity and access to school libraries under Title IV, Part A (Student Support and Academic Enrichment Grants).

Thanks again for ensuring that effective school library programs were included as part of S. 1177, the Every Student Succeeds Act. ALA is pleased to support this critical legislation.
