Becoming and Intern

To apply for a committee internship all you have to do is fill out the standard ALA committee volunteer form and indicate where appropriate that you wish to serve as an intern. The online committee volunteer form can be found on the ala website.

Each year the form must be completed and submitted by December for appointments to committees the following year. For example, the due date to submit the form to apply for a 2007-2008 committee appointment was December of 2006.

Frequently Asked Questions

1. Who can become an intern?

Anyone who has not held an ALA office or been appointed previously to an ALA committee may become an intern.

2. How long is the appointment?

Interns are appointed for a two year period.

3. What are the duties of an intern?

The duties of an intern may vary depending upon the committee they are appointed to. Some committees will ask their interns to take minutes or complete special projects. Other committees treat their interns just like the other committee members.

4. Do interns get to vote?

Just as the intern's duties may vary from committee to committee, so to will their voting status. Some committees give their interns a vote, while others chose not to do so.

5. Do I have to go attend midwinter and annual?

Interns are expected and required to attend both the midwinter and annual conference and participate in the meetings of the committee.

6. What happens after my internship ends?

After the end of an internship, interns are considered for appointment to another ALA committee as a full member.
