DRAFT OF MOTION:

The ALA Executive Board approve Philadelphia as the official location for the ACRL 15th National Conference on the dates of April 7-10, 2011, and Indianapolis as the official location for the ACRL 16th National Conference on the dates of April 4-7, 2013.

DATE: June 9, 2006

BACKGROUND:

ACRL has a strong 28-year history of successful National Conferences, beginning with our first conference in Boston in 1978 and most recently with our 12th National Conference in Minneapolis, April 2005. More than 9 out of 10 attendees (97.4%) characterized their experience at the 2005 ACRL National Conference as either "very" or "somewhat positive." Selected comments from the 12th National Conference evaluation and the ACRL 2005 Membership Survey are below:

- "I am very impressed with the ACRL conferences. I have learned more while attending them than from any other conference."
- "I find ACRL conferences to be a great experience - a blend of theoretical issues and practical application. ACRL conferences directly apply to my work."

- “The information presented and networking with other academic librarians are the two best aspects of this conference. The conference has an overall good feeling and is well organized, so it is a pleasure to attend.”
- “A very worthwhile experience It made me proud to be a librarian!”

Requests for proposals to host ACRL’s National Conferences for 2011 and 2013 were issued last October. Per ACRL’s Guide to Policies and Procedures, staff researched sites that have the appropriate meeting and exhibit space, adequate hotel rooms close to the convention center, easy accessibility for air and ground transportation, reasonable rates for meeting space and hotel rooms, and date availability.

Based on each city’s proposal, site visits by ACRL staff, availability, and costs, Philadelphia was recommended to the ACRL Board of Directors as the official location for the ACRL 15th National Conference and Indianapolis was recommended to the ACRL board as the official location for the ACRL 16th National Conference. The ACRL Board of Directors approved these recommendations during their meeting at the 2006 Annual Conference.

ACRL is committed to a geographic rotation of its conference location to afford more members the opportunity to attend. In addition, ACRL looks for conference dates in March or April that avoid all major holidays and similar conferences while avoiding scheduling too closely ALA and other major division’s conference locations. As demonstrated by the chart below, this motion meets those requirements.


