

## **LICENSE AGREEMENT FOR PROMOTIONAL MATERIALS**

This license agreement (the "Agreement") governs the terms by which Library Members may download specific DC Comics-owned Teen Titans artwork (the "Artwork") from the American Library Association ("ALA") for use on library cards free of charge ("Library Cards"), physical bulletin and billboard artwork ("Billboards") (collectively, "Promotional Material") in conjunction with ALA's Library Card Sign-up Month to promote libraries ("Event")..

Please read this Agreement carefully and sign and return this Agreement before downloading any Promotional Materials. By downloading any Promotional Materials, you agree to be bound by the terms of this Agreement. If you do not agree with the terms of the Agreement, do not download any Promotional Materials.

With download of the Artwork, ALA grants the Library Member a license to use the Artwork, but only within the context of the Promotional Materials and subject to the conditions below.

1. ALA authorizes the above stated Library Member to reproduce the Artwork as incorporated in the Promotional Materials, provided that the Artwork may not be carried over or excerpted by the Library Members in other publications, advertising or used for any other purpose, or modified in any manner except that it may be reduced or enlarged in order to create the Promotional Materials, without obtaining DC's prior written permission.
2. This permission covers the distribution of the Promotional Materials, throughout the world, from June 1, 2017 through August 31, 2018. Upon expiration of this Agreement, Library Member shall have the right to distribute any remaining inventory of the Library Cards for a period of 180 days after expiration of this Agreement; after such 180 day period, Library Member shall cause all Billboards to be promptly taken down or removed.
3. Library Member warrants and represents that it will not use the Artwork in any way that would be morally or socially unacceptable, or that would in any way detract from or adversely affect the reputation of DC or its rights in and to the Artwork or the Properties, and that it will indemnify DC, its parent company, affiliated companies, assigns, licensees and successors in interest and each of their officers, directors and employees, from and against any and all claims, actions, damages, costs and expenses, including attorneys' fees, arising out of any breach of any of the warranties or representations made by Library Member hereunder.

## **PROHIBITED USES**

Library Member may not do anything with the Promotional Materials that are not expressly permitted in the Agreement. All Library Members are subject to the following terms and conditions:

1. The Promotional Materials are for use by non-profit entities for the sole purpose of promoting libraries and the Event (the "Purpose").
2. The Promotional Materials may not be used by any individual or entity that is for-profit and may not be incorporated in products offered for sale or used for commercial, advertising, or marketing purposes other than in furtherance of the Purpose. For sake of clarity, no for profit entity may sponsor, promote, be affiliated with or otherwise use the Promotional Materials for any purpose. Use of any for profit entity, name, logo or trademark on or in connection with the Promotional Materials is expressly prohibited.
3. The Promotional Materials may not be incorporated in a product for the purpose of redistributing the Promotional Materials, and the Promotional Materials may not be sold, relicensed, rented, or made available for download by third parties.
4. Pornographic or defamatory use of the Promotional Materials is prohibited.
5. All copyright notices or other statements of attribution contained in the Promotional Materials may not be removed for any reason.

# ALA American Library Association

In the event that Library Member shall fail to comply with any term(s) and condition(s) of this Agreement, ALA shall have the right to immediately terminate this Agreement and all rights granted to Library Member hereunder shall thereupon be rescinded and Library Member shall have no further right to use the Artwork.

ALA has the right to review Library Member's use of the Promotional Materials and to request that the use cease or be changed. Library Member agrees to comply with any such request made by ALA.
