From the President:

Where are we going? Are we in step with those we serve? How are we doing? Federal librarians cover a broad spectrum of library environments. Many librarians represent an agency that only serves personnel within the agency. Others reach out and serve a broader, more diverse clientele. Military librarians serve a variety of patrons. General community libraries are quite similar to small public libraries. Special and academic libraries provide mission support to their clientele.

Where are we going? If we begin by looking back at our past choices and how successful they were, we ask if they accomplished what we intended? When we recommended the purchase of a new library management system we needed to be sure that it's functions would benefit our clients. Does the system work so that it locates the information our clients want? Can our staff explain its use easily to our users? Answers to these questions are important and affect the outcome of a successful implementation.

Are we in step with those we serve? If our collection of electronic sources provides exactly the information that our clients need, then we have gone a long way in serving them. If they are able to obtain the

information quickly and efficiently, then we have provided responsive service. When our clients provide us with positive responses to our services and come back again and again, then we are on the right track. By analyzing our service one client at a time, we will be able to broaden our perspective on how to better serve the information needs of our clients.

How are we doing? Can we meet challenges that are presented to us? Sometimes when a new issue arises we must pursue the challenge by leaping ahead to solve it without fully understanding how we are going to do it. Last summer we had to pack and move our entire collection of some 95,000 items, including book stacks, furniture and equipment, for construction of a mezzanine for the library book stacks. The move had to be completed in a month. We had a plan in the beginning, but once the move was in progress our original plan changed daily. If we had not moved ahead from the beginning thinking we could accomplish this project with the resources we had in the time allowed, our construction project would never have begun on time.

Why was it so imperative for the project to begin on time? Because we need to get the library finished by

the end of Christmas break. While under construction we moved the audio-visual, current subscriptions and some of the library computers to a small service area next door to the library. The book collection was moved to the general library. With our new system we were able to test the user interface as users could request books online from their library account. When we receive the requests we pull them from the other library and deliver them within the next day to our service area.

Currently, we are in the middle of the project and everyone misses the library, especially our students. One day last week as I was walking by the library a student was showing his dad around the post. As they walked in back of me, I overheard the student say, "...here is our library. They're doing some kind of renovation now. It's a really nice library; they have a lot of stuff. I hope it's finished soon..." And I hope all our users are happy with the library when it is completed. I am sure that everyone involved in the project will meet the challenges still ahead and move forward to provide a library everyone can be proud of.

Secure STINET + WED = Private STINET

Private STINET, DTIC's newest online service for registered users, was launched March 25, 2003 and replaced DTIC's Secure STINET and Web Enabled DROLS (WED). With the discontinuation of both Secure STINET and WED, Private STINET combines the special features and collections of Secure STINET with the search capabilities of WED and offers access to the information resources previously available on these two systems. Private STINET is a password protected system, and access to information will be based on user privileges determined during the registration process.

Private STINET offers registered DTIC users many beneficial features.

Access to the complete DTIC collections:

Technical Reports (TR) Database of all unclassified, unlimited (U2) and unclassified, limited (UL) citations with no cutoff accession date (including sanitized citations to classified citations)

- Research Summaries (RS) Database
- Independent Research & Development (IR&D) Database
- Research and Development Descriptive Summaries (RDDS)
- DTIC Thesaurus of subject terms (descriptors) with hierarchy searching capability
- DTIC Corporate Sources (corporate source codes) with hierarchy searching capability
- Multiple database searching
- Access to over 203,000 U2 and UL full text documents
- Ability to order documents and electronic bibliographies.

Access to several information sources that assist DTIC users with their mission:

- U.S. and international journal databases
- Language translator
- DOD Specifications and Standards
- DOD Index of Security Classification Guides

- Militarily Critical Technologies List (public release version or limited versions based on user profile)
- Numerous links to other DOD sites and mission-related sources.

Access to one organized, comprehensive site for registered DTIC users:

- Providing service at no charge except for document orders
- Requiring only one password/ID for access.

Registration:

Current registered DTIC users who need access to Private STINET must re-register using the new online registration process at http://www.dtic.mil/dtic/registration/lap_reg.html. During the online registration process, applicants will create their own password that will provide access to DTIC's unclassified online services. Some registrants will receive new DTIC user codes because DTIC is moving from organization assigned user codes to individual user codes. Registrants who need other DTIC products or services should contact the DTIC Registration Team. New DTIC users must also register using this new process. Fabulous Feds

The Library of Congress Professional Association Continuing Education Fund celebrated 20 years by awarding 37 study grants totaling \$14,761 to members for 2003-2004. This is the largest amount ever awarded to the largest number of recipients. It exceeds the previous year's record amount of \$10,015 by nearly \$5,000. The grants are used for courses ranging from library science to computer programming and also for seminars and conferences. The fund receives contributions from members and some of the proceeds of the annual book sale. Donations made in honor of colleagues or in memory of people who have passed away are another source.

A named grant was established in honor of Winston Tabb, the former Associate Librarian for Library Services, on the occasion of his retirement last year. Nora Yeh of the American Folklife Center received the first Tabb grant to attend a conference sponsored by the Society of American Archivists. When Judy Herrick, the Serials Selection Officer and former serials cataloger retired in 2002, her colleagues established a grant in her honor and Fabulous Fed Judy matched this amount. The Herrick grant went to Nancy Alfaro and Michael Kardos for library science courses at Catholic University. A grant to honor Barbara Conaty who left LC for the State Dept. went to Anchi Hoh Dianu for a library science course at the University of Maryland. The grant in honor of Pam Dragovich who left for the State Dept. earlier enabled AnnLian Kruger Grossmen to participate in a seminar on manuscripts at the Arnamagnaen Institute in Denmark.

The current trustees of the fund are all Fabulous Feds (Abby Yochelson, Georgia Higley, and Sara Striner.) The fund fills a niche not met by other sources of training funds at LC. Members may apply for a grant as they work on a degree or take a course to enhance their job performance or to expand employment opportunities.

At the Oct. 31 retirement reception for Mary Costabile, Associate Director of the ALA Washington Office, federal librarians were seen: Peter Young, NAL; Jane Sessa, Dept. of Commerce, Shirley Loo, LC, and retired GPO librarian Andrea Gruhl. Bernadine Hoduski, 2002-2003 chair of the ALA Committee on Legislation, and former Joint Committee on Printing staff member was also present. Bernadine was the speaker for DCLA on Nov. 3, "Advocating for Libraries". Her book, *Lobbying for Libraries and the Public's Access to Government Information* was recently released by Scarecrow Press.

Maxine Becker was recently appointed Librarian of the Community Library, Guantanamo Bay Naval Station. Maxine was previously Director of Library Services at the College of the Marshall Islands. She has worked in special libraries and public libraries as well as in academic settings. Now she can add military libraries to the list. Her MLS is from Western Michigan University and she says she will never live in a cold climate again. Maxine met the Atlanta Falcon cheerleaders when they visited the area and she says that it was "quite an experience".

Susanne Perella, director of libraries and information services at the Treasury Department from 1992 to 1997, died of

cancer Oct. 22. Susanne also served at the Federal Trade Commission from 1972 to 1992 as head of reader services and then as library director from 1979 to 1992.

Ruth Fine's bequest of close to \$500,000 to the University of Michigan library school established the Morris and Ida Fine Scholarship in honor of her parents. The full tuition scholarship so far has been awarded to three students with a strong commitment to public service. Ruth retired in 1972 as director of the Office of Management and Budget Library. Her bequest to DCLA have resulted in four students being granted \$5,000 student loans. One student has graduated from Catholic University and his loan has been forgiven by DCLA with his superior academic achievement. Two more students will be selected in the spring of 2004 (see www.dcla.org for details).

IFLA is disappointed that its concerns about the USA PATRIOT Act and the 2002 guidelines issued by the Attorney General have been justified. IFLA supports initiatives taken by the American Library community to protect the privacy of their clients."
