IFRT Executive Committee Meeting Wednesday, September 16, 2020

I. CALL TO ORDER/WELCOME:

Huffaker called the meeting to order at 2:04pm CDT. A quorum was established.

II. INTRODUCTIONS

We introduced ourselves and talked about what is going on in our libraries now.

III. REVIEW AND APPROVAL OF AGENDA

Barbakoff moved to approve the agenda. Hull seconded. The motion carried, and the committee voted to approve the agenda.

IV. REVIEW AND APPROVAL OF MINUTES

Hull moved to approve the <u>meeting minutes from July 15, 2020</u>. Hartman-Caverly seconded. The motion carried, and the committee voted to approve the minutes.

V. REPORT OF OFFICERS

- A. Chair: Wanda Huffaker
 - i. IFRT's Treasurer, Ashley Brown, has found it necessary to resign her position. The bylaws state that the chair can appoint a replacement with board approval. Huffaker has appointed Steve Norman to



- complete Ashley's term. Barnaby moved that the board approve this appointment, Kratz seconded. The motion passed.
- ii. Huffaker reminded us to review the Executive Committee section of the IFRT Handbook, especially about how to formally endorse resolutions. This will be more important as we approach ALA Midwinter, but it's good for us to understand the protocols and help her do things right.
- iii. Huffaker has been participating in the Round Table Coordinating Assembly task force, which came out of the SCOE process. The group is working on a template for standardized round table bylaws, and Huffaker has asked Trish Hull and the bylaws committee to take over that effort for IFRT.
- iv. Our Round Table membership has dipped below 1,000 members, and Huffaker is looking for more ideas to engage members. Ideas that came out of a joint meeting of the Membership and Education committees include holding a regular IFRT Salon; a monthly Zoom get-together on a Saturday. This would be a casual chat ("speakeasy") about issues of importance to intellectual freedom. Another idea is Friday Happy Hours, a super casual start to the weekend with no agenda, just a social to get people together.
- B. Director at Large: Stephanie Barnaby
 - i. Set up a spreadsheet of Fridays for Happy Hour coverage. A long conversation ensued about the Friday/Saturday Zoom events. Hartman-Caverly noted that the Scary Stories watch party is envisioned as the first of these IFRT events. Vasquez will work with Huffaker and Barnaby to develop questions, and will poll Scary Stories participants via Twitter about their interest in future events. Pekoll will share the meeting minutes, so we can continue this conversation online.
- C. Director at Large: Angela Ocaña
 - i. Likes the idea of the Salon or Happy Hour as a way to engage new members. She is hearing from members that ALA feels more accessible now that conferences are online and more affordable. Our efforts can help engage this audience of younger librarians.
- D. Director at Large: Jeremy Brett
 - i. Nothing to report, but agrees with Angela.



VI. REPORT FROM COUNCILOR: Martin Garnar

- A. ALA Council has held two of <u>six meetings with a Forward Together working</u> group, focusing on how the proposed recommendations would play out.
- B. Garnar mentioned his <u>Connect post</u> about adding a seventh standing committee for professional values, which is where IFRT would likely live. If the Forward Together working group gets enough feedback from enough people, they may add that committee to their recommendation. The group is still collecting and considering <u>feedback</u>, if you'd like to add your support for this idea, or make any other comments.
- C. About 70 of 100 councilors have been attending these meetings, so conversation is not as robust as Garnar expected. There are concerns about diversity (geographic, library type, etc.) in new structure. Council is meeting much more frequently than ever, now that they're meeting remotely. Budget discussions are on the agenda for the next meeting.

VII. REPORT FROM OFFICE FOR INTELLECTUAL FREEDOM: Kristin Pekoll

- A. Banned Books Week is coming up in less than two weeks (Sept. 27-Oct. 3). If you visit the IFRT Facebook page, Ellie did a series of posts about book challenges as a countdown to the week. There are a lot of program ideas and events on ALA's Banned & Challenged Books page, and the OIF is involved in the Scary Stories documentary watch party, Dear Banned Author letter writing campaign, and the video premiere of Books on the Chopping Block, a series of dramatic readings from Chicago's CityLit Theater.
- B. <u>ALA Connect Live</u> is a monthly ALA-wide membership event, hosted by president Julius Jefferson. On Thursday September 24th, 1pm CDT, Jefferson will be joined by ALA Intellectual Freedom Committee Chair, Martin L. Garnar, and Freedom to Read Foundation President, Barbara Stripling for this program, scheduled the week prior to Banned Books Week.
- C. Pekoll asked how we want OIF staff to keep us up to date on meeting dates. Would a master calendar be beneficial? Vasquez expressed some interest, and we said we'd discuss over Connect. Please comment on the draft.


VIII. COMMITTEE REPORTS
