The first SRRT Action Council meeting of the 1983 Midwinter ALA Meeting was held on Saturday, January 8. The meeting was called to order by the AC Coordinator, Linda Pierce.

1) The first item of business was the state of the budget, to update the financial situation of the round table and ascertain what money was available for AC and task forces to use as planned. Treasurer Jeanne Kocsis explained that the crisis freeze on spending during the fall of 1982 was precipitated by the bills received after the deadline for 1981-82 fiscal year spending, but which actually were expenses from that year. Another factor is the fact that the round table is no longer living within its income, but has been budgeting based on need and activities of the task forces and AC, using the reserve which had been built up for a few years. David Cohen asked for a change to \$100 for the Ethnic Materials TF, to finish up the time as a SRRT TF, before the group becomes a separate round table later in the year. Bonnie Jo Dopp suggested that handbooks or manuals of procedures be developed to be passed along by TF coordinators, to try to avoid some of the procedural problems such as turning bills in after the end of the fiscal year during which the expenses occurred. AC decided that the allocations as decided upon at the 1982 Annual Conference AC meeting would be reinstated, with Ethnic Materials TF allocation decreased to \$100 and with the proviso that each TF should attempt to decrease their spending this year. Discussion to follow at later meetings about how to increase the income of the round table, through dues increase, membership increase, etc.
