



# YA Advocacy Travel Stipend

## About the Stipend:

YALSA's YA Advocacy Travel Stipend will enable five qualified recipients to receive up to \$1,000 to attend ALA's 2011 National Library Legislative Day, which will be held in Washington, DC, April 23-24, 2012. Applications must be received in the YALSA office by December 1, 2011 via email to [yalsa@ala.org](mailto:yalsa@ala.org).

## Eligibility Requirements for Applicants:

- YALSA personal membership
- No previous attendance at or participation in an ALA Library Legislative Day

## Application Guidelines:

1. Submit your application electronically on the official application form.
2. All applicants must be current, personal members of YALSA at the time of application.
3. All documents must be named the last name of the applicant, underscore, name of document. For example: gilbert\_application.doc.
4. MS Word documents or PDFs will be accepted.
5. Applications must be submitted as an attachment to YALSA at [yalsa@ala.org](mailto:yalsa@ala.org).
6. Applications are due no later than Dec. 1, 2011.
7. Incomplete submissions will not be considered.

## Criteria for Selection:

- Candidate's commitment to young adult library services
- Candidate's desired learning outcomes for attending the event
- Candidate's financial and professional development needs
- How the applicant intends to use the experience at his/her home institution
