I always seek to reduce barriers to learning and access, especially for the communities of teachers, graduate students, and teacher educators I currently serve.

For over 17 years, I've worked in public and academic libraries in America and China and held leadership positions within ALA, ACRL, National Associations of Librarians of Color, and IFLA. As President of the Asian Pacific American Librarians Association and the Chinese American Librarians Association, I've forged local and global coalitions, streamlined governance processes through transparency, and increased fiscal health and membership through fundraising and engagement, especially during COVID-19. Cultivating meaningful connections among our volunteers is purposeful work. I would continue to bring this intentionality to ALA, collaborating with other members to calibrate and communicate its impact, values, and growth areas amidst our rapidly changing yet emotionally exhausted profession.

I aim to strengthen ALA's role in bridging global learning and local library advocacy networks and highlighting the invisible and emotional labor of library workers, our ALA, and ALA-APA colleagues. I thank countless volunteer leaders for inspiring me to run.

Statement

Libraries and library workers are under an almost unprecedented level of attack in the United States. Every day brings more news of attempted book bans, bomb threats, and library workers being harassed or fired. The American right wing -- both on Twitter and from the statehouse -- demands that we suppress the history not just of racism, sexism, transphobia and homophobia, but also the stories of success and joy that people of color and queer people have managed to claim for themselves. Merely being a library worker of color, or a queer librarian, is enough to make one a target, and ALA itself has been targeted for electing such colleagues to leadership positions. We have to fight back, as people and as an organization. ALA has a long way to go to truly be an organization that stands fast against bigotry, but if it doesn't embrace that path then it is not ready for the moment we find ourselves in. If elected, I would do everything I could to help support the transformation of ALA into such an organization, and push back against those who attack our colleagues and our work.
