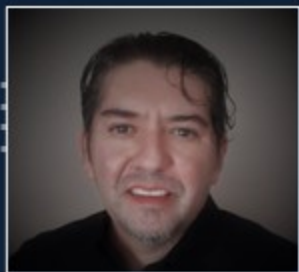
Nominations may be made from the virtual Council floor on Monday, June 28, 2021 during Council I Session. To be eligible for:
