## New Leaders














# Membership

Along with many other divisions, ALA itself, and professional organizations in general, LITA is experiencing a decade-long decline in membership. For LITA, membership, revenue, and organizational stability go hand in hand. The Board remains focused on improving the member experience; education opportunities, conference programming, and social media presence all contribute to the overall strength of the division. There is no one "right" size for LITA, but our target energy level ("high!") and value to members ("really high!") will continue to drive the Division forward.





## New Committees and IGs

Much of LITA's work is carried out by volunteers serving on our 24 standing committees, four current task forces, and the editorial board of *ITAL*, our peer-reviewed journal. Two committees were formed this year and will begin work in 2016/2017:

The **Appointments Committee** takes on the essential role of helping the vice president/president-elect match volunteers with open roster positions.

The **Diversity and Inclusion Committee** has been convened to maintain diversity as a fundamental principle of the Association, and to work throughout the Association to help realize our diversity goals.

LITA also features a wealth of interest groups (IGs) formed by LITA members to address emerging trends, technologies, and issues. Four new IGs were created this year:

Women in Information Technology IG (founding co-chairs, Abigail Goben and Zoe Stewart-Marshall). Established to provide a forum and support network for individuals interested in issues and opportunities related to women in information technology fields.

**LITA New Member IG** (founding chair, **Jake Ineichen**). Established to create pathways to participation in LITA.

**E-Rate and CIPA Compliance IG** (founding chair, **Vicki Teal Lovely**). Established to provide a forum to discuss the E-Rate application process and CIPA compliance.

Additionally, the 3-D Printing IG was renamed the **Maker Technology IG** (chair, **Amanda Goodman**).

This year, the Guides completed their move to our publishing partners at Rowman and Littlefield. Seven titles have been published or are available for pre-order.


















## LITA National Forum







The 2015 LITA National Forum was held in Minneapolis, November 12 - 15. 274 people attended, including 135 LITA members. Attendees heard keynote addresses from Lisa Welchman (President of Digital Governance Solutions, ActiveStandards), Mx. (Mark) Matienzo (Director of Technology, Digital Public Library of America), and Carson Block (Carson Block Consulting). The Forum Planning Committee (Zoe Chao, chair) also selected 57 presentations on a range of



topics spanning altmetrics, linked data, cybersecurity, project management, and user experience design.



The 2016 National Forum will be held in Fort Worth, Texas, on November 17 - 20. Announced keynote speakers include **Cecily Walker** (Vancouver Public Library), **Waldo Jaquith** (Director, U.S. Open Data), and **Tara Robertson** (@tararobertson). The Forum Planning Committee (**Tammy Allgood Wolf**, chair) is currently reviewing session proposals.







# LITA @ Midwinter

LITA activities at Midwinter included a tour of two notable maker spaces: <u>Artisan's Asylum</u>, a facility with 40,000 square feet of 3D printing, woodwork, metalwork, machining, artists' workshops; and <u>Parts and Crafts</u>, a neighborhood makerspace for kids that runs camp, afterschool, and homeschooling programs.

Our regular activities include the LITA Open House, an opportunity for new and prospective members to meet the Division's leaders and "old hands" to do some networking, get information on opportunities for volunteering, and learn about the benefits of membership.

The LITA Town Hall meeting, lead by **Aimee Fifarek**, continued 2015 meeting's discussion on strategic directions. Input from both meetings will inform the

Board's ongoing work towards a new strategic plan.

LITA's signature event, Top Tech Trends, covered topics ranging from our interactions with robots and Al assistants, to the balance of analytics data and privacy, to peer-to-peer data security with blockchains.

Of course, no ALA meeting is complete without LITA Happy Hour, held at the MIJA Cantina and Tequila Bar. There was good company, good drinks, and good food—and a couple of new interest groups came together too!
