conference being held in Dubai, but we need to try to support people NOT attending due to

safety. We maybe can advocate for sending delegates that will be safer, instead. IFLA

LGBT group has made a statement that we should uplift. John DeSantis was able to attend

the IRC meeting yesterday, and updated. Erin plans to ensure Council will be addressing

this at this conference to make a statement. Nadia will reach out to IRT to see if they are

drafting a resolution to bring to Council.
