In 2021, as Denver Public Library locations reopened, it became apparent that a coordinated all format, all ages EDI focused advisory services platform was needed to streamline the process in light of staff shortages and potential for duplication of effort at a 27 branch library system. A committee was formed representing adult, teens, and childrens advisory to create a framework for institutional advisory processes and services. Using a flexible form to address advisory needs across the system, all staff are now able to collaborate on this key service, from booklists to blogs to Core Collections.
