YesElections is pleased to announce the compiled results of the American Library Association (ALA) 2024 Election for the American Library Association. We have ensured that all aspects of the administration of your election were executed in accordance with requirements provided for the American Library Association (ALA) 2024 Election.

The voting period ran between March 11, 2024 and April 3, 2024. 8,695 ballots were cast with one ballot marked as void, resulting in 8,694 valid ballots successfully cast.

On February 16, 2024, YesElections sent a pre-election email to determine bounce backs. For members without a valid email address on file, YES mailed a notice letter via USPS First class mail in an official depository under the exclusive care and custody of the U.S. Postal Service within New York State on March 8, 2024.

An initial email was sent at opening and three reminder emails were sent throughout the duration of the election period to only those members who had not voted or who had not completed their ballots. The emails and paper notice letter contained all of the necessary information needed to participate in the election, including a URL link that took the voter directly to their online ballot after logging into ALA's member portal. By logging into ALA's site, this authenticated the voter, verifying that they were an eligible member.

YesElections performed a QA Results test of the ALA election event on March 1, 2024 to review the online ballot and test the quality control procedures. We utilized 61 sets of credentials to vote online ballots. A voting record is saved for each ballot, then the election event is decrypted to obtain the QA Results. A comparison of the voting record and QA Results showed no errors during this process.

Additionally, a Proof Test was conducted on March 1, 2024 by YesElections, to perform an additional review of the online ballot and quality control procedures with the voter list provided by ALA. ALA's support staff was also given the opportunity to spot check the voter list for appropriate ballot style eligibility in the Proof phase of the election event. No errors were present during this process.

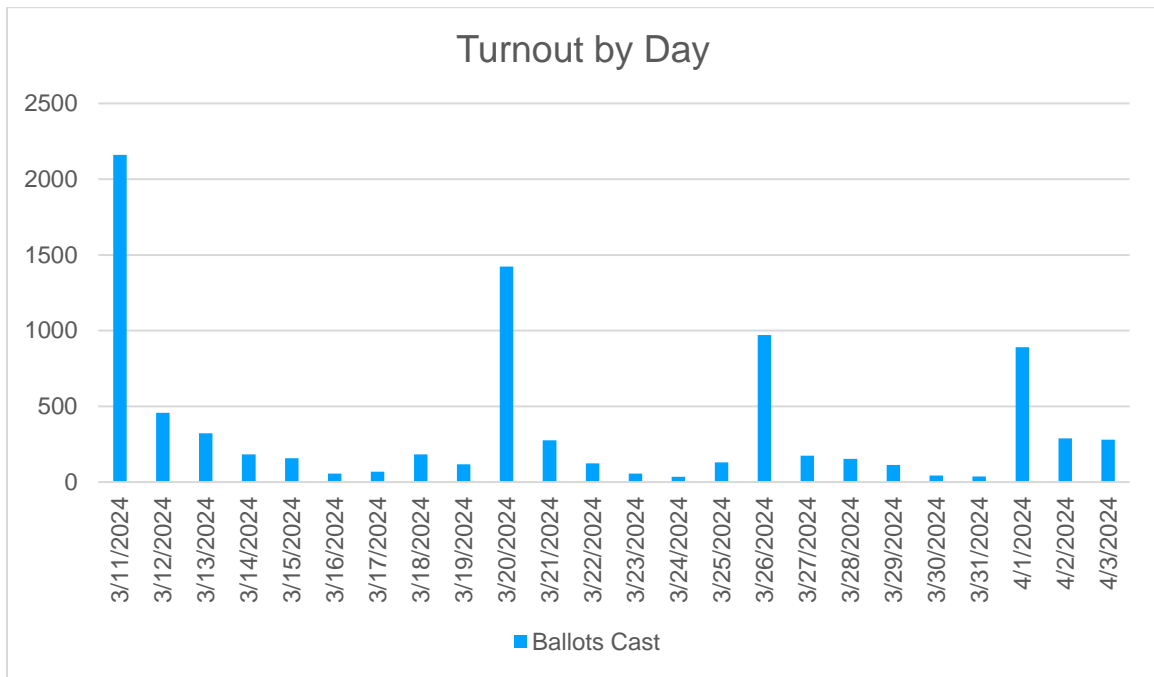
