FREQUENTLY ASKED QUESTIONS

Q: Does registration include the book, All Ages Welcome: Recruiting and Retaining Younger Generations to Library Boards, Friends Groups, and Foundations?

A: No, registration does not include the book.

- Madeline Jarvis and Kathy Kosinski, co-authors of *All Ages Welcome: Recruiting and Retaining Younger Generations to Library Boards, Friends Groups, and Foundations*, will present on recruiting Friends. During the retreat, participants will complete an interactive activity excerpted from the book. The main contact will download this activity from the course before the live retreat.
- Registration includes a coupon code to save on the book's print and/or digital version available from the ALA online store.

Q: How does Group Viewing registration work?

A: The person who redeems the signup code is the main contact. This person coordinates group viewing at the library or another location, including:

- Securing a computer/laptop, projector, screen, and speaker(s)/audio capability.
- Accessing the course on the ALA eLearning website to download slides, handouts, and activities, and providing copies to their Friends group
 participants on the day of the live retreat.
- Receiving the Zoom link for the live retreat. Access from multiple devices is disabled, however, accommodation is available for board members who need individual viewing from a separate location. Once enrolled in the course, please see the "How to Participate" page for more details.
- Coordinating on-demand group viewing; logins cannot be shared.

Q: My library director is a personal member of United for Libraries. How do I receive their member discount?

A: The person who purchases registration (Individual or Group Viewing) will receive a signup code. The signup code is redeemed by the individual (Individual Registration) or main contact (Group Viewing Registration) for course registration.

- When purchasing online, the member must be logged in and complete the purchase to receive the eligible member discount.
- When requesting an invoice, the member must contact registration@ala.org to receive the eligible member discount.
- When purchasing registrations of the same type (three or more Individual Registration *or* three or more Group Viewing Registrations), the member discount is applied first, and then the additional discount for multiple registrations is applied.

Q: I'm an ALA member in one of the listed statewide partner states eligible for a 20% discount. Will I receive both discounts?

A: The higher eligible discount (member or statewide partner) will apply.

- The higher eligible discount (member or statewide partner) is applied first to the base price.
- The eligible discount for purchasing three (3) or more Friends groups is applied after the eligible member or statewide partner discount. See the last question at the end of this document for examples.

Q: I'm in one of the states listed for free registration. How does registration work?

A: Please complete the registration form to receive your free registration.

- Individuals in MA, MD, MI, MN, ND, NE, OR, SC, and VA receive free registration to attend individually or participate in groups; each person will receive a Zoom link and course access.
- Friends groups in these states are encouraged to participate as a group to maximize engagement and group activities. Those who opt to participate as individuals will be placed randomly in Zoom breakout rooms for group activities.

Q: What is the difference between purchasing Individual registration for each of my board members versus purchasing a Group Viewing registration?

A: To determine which option is a better fit for your Friends group, consider the following:

- If you purchase Individual registration for each of your Friends board members, they will each receive (1) their own personalized Zoom link, (2) access to the course to download slides, handouts, and activities, and (3) access to the course for on-demand viewing of the presentations.
- If you purchase Group Viewing registration, accommodation is available for board members who cannot join the group viewing in person; however, please note that course access to download slides, handouts, and activities, and access to the course for on-demand viewing of the presentations is limited to only the main contact. Sharing of logins is not permitted.

Q: My Friends group is not available to participate live on March 22, 2025; however, I want to participate live. If I purchase Group Viewing registration, can my Friends group watch the recording at a later time?

A: Yes, the main contact (the person who redeems the signup code) may attend live as an individual and show the recording later to their Friends group. The main contact receives the Zoom link for the live session, is registered in the course, and has access to all course materials, including ondemand access to the recording. Sharing of logins is not permitted. The main contact must coordinate on-demand group viewing.

Q: How will group activities and breakout rooms work be handled for the live retreat?

A: Participation depends on the type of registration purchased. Please note that breakout rooms will not be recorded.

- Individual Registration: Attendees will be placed in random breakout rooms.
- Group Viewing Registration: Each group will complete activities and breakout discussions in their location.
 - o If you request accommodation for board members to join from their own location, a limited number of group-specific Zoom breakout rooms are available. Once you are registered in the Group Viewing course, please refer to the "How to Participate" page for more details.

Q: How many people are included in Group Viewing registration?

A: This retreat is designed for a standalone Friends group to assemble in a single location and view on a single screen. You may include library staff. Please refer to the next question if your library system has multiple branch Friends groups.

- The main contact who redeems the signup code will be registered in the course and have access to the slides, handouts, and on-demand recordings. The main contact will receive a Zoom link one week before the live retreat.
- Zoom access from multiple devices is disabled; however, accommodation is available for board members who need individual viewing from a separate location. Once enrolled in the course, please see the "How to Participate" page for more details. Sharing of logins is not permitted; live attendance and/or on-demand viewing must be coordinated by the main contact.

Q: My library system has branch Friends groups. Can we assemble in a single location and pay for one registration?

A: Each registration is valid for a single, standalone Friends group. If your library system has multiple Friends groups, you can purchase three (3) or more Group Viewing registrations at a discount.

- The higher eligible discount (member or statewide partner) is applied first to the base price.
- The eligible discount for purchasing three (3) or more Friends groups is applied after the eligible member or statewide partner discount.
 - o For 3-6 Friends Groups: save an extra 30%
 - o For 7-12 Friends Groups: save an extra 35%
 - o For 13+ Friends Groups: save an extra 40%
- Group Viewing Registration Examples
 - o A library system in CO, IL, or NV has six (6) branch Friends groups. The cost for each group is \$83.44.
 - o An ALA personal member's library system has seven (7) branch Friends groups. The cost for each group is \$87.17 per group.
 - A United for Libraries personal member's library system has four (4) branch Friends groups. The cost for each group is \$67.80.
