Accomplishments [at this meeting], a concise account:

<u>Issues that affect the committee's work and their implications for the future:</u>

The committee continues to feel that the timing of document review is problematic. There is not enough time to review and discuss as a committee before offering endorsements.

Interactions with other units within ALA:

The committee appreciates the engaged participation of liaisons from YALSA, ASCGLA, ACRL, and LITA. They hope to continue to have the support and involvement of ALA units in the conversations of professional ethics.

Relationship of the committee's work to the ALA strategic plan:

Not much attention was devoted to the ALA strategic plan this year but we will reflect on the committee's role and how to strengthen the mission of ALA in the future.

<u>Current level of committee members' involvement:</u>

With specific projects to work on, the committee attendance and involvement has increased.

Committee self-check on its value and viability:

The general consensus is that the committee is undervalued and unknown. The representatives from units across the Association bring up valid concerns that the Ethics committee is willing to work on but there is little awareness of the committee and its charge to the greater organization. A few members that were appointed to the committee were not aware of its existence prior to appointment.
